In the spotlight: Brexit and the EP elections

Brexit and the 2019 European Parliament elections have surely caught the attention of the academic community at the Faculty of Arts and Social Sciences and at the Faculty of Law in this academic year 2018-2019. For instance, the Jean Monnet Lectures hosted by CERiM all looked at the upcoming elections, albeit from different angles. Possibly the most contested issue approaching the elections, namely the Spitzenkandidaten process, was then explored in theacademic debate featuring Thomas Christiansen and Diane Fromage, hosted in collaboration with the Maastricht Centre for European Law (MCEL).

Another joint CERiM & MCEL conference brought together many CERiM members and a wide array of different <u>legal and political perspectives on Brexit</u>, from the Irish backstop to what will Brexit mean for EU Agencies. CERiM members were also invited to speak about Brexit in several other occasions, such as the <u>Expert Roundtable 'Brexit and Beyond'</u> including Patrick Bijsmans and former CERiM fellow Oriane Calligaro, or the conference <u>'Surviving Trump, Brexit and the BRICS: How Europe can stand up for global governance'</u>, featuring Thomas Conzelmann, Hylke Dijkstra, Anke Moerland and Andrea Ott. Jean Monnet Lectures

In the academic year 2018-2019, CERiM organised four Jean Monnet Lectures, all related to the upcoming European Parliament elections.

On 18 October, we hosted **Ryan Heath**, Political Editor at POLITICO Europe. In his lecture 'The first real European election?', Ryan engaged with the audience in a discussion about what makes the 2019 elections so important for the future of Europe. On 13 November, in collaboration with the Ambassador Lectures Series, we had the honour to listen to **Alberto Alemanno**, renowned academic, civic advocate and social entrepreneur, discussing his expectations for the elections and the emergence of transnational parties. As the elections were coming closer, on 7 February we had the opportunity to discuss predictions, polls and candidates with **Sophia Russack**, Researcher at CEPS and PhD candidate at Maastricht University. This was in fact the first Jean Monnet Lecture delivered by a Maastricht University researcher and alumna. Finally, on 28 March, **Luuk van Middelaar**, Professor of Foundations and Practice of the European Union and its Institutions at Leiden University, joined us in

Maastricht to present his new book 'Alarums and Excursion: Improvising Politics on the European Stage' and to discuss how the crises of the past years will impact the upcoming elections. Sadly, this was also the last Jean Monnet Lecture hosted by Michael Shackleton, whom we thank for his precious contribution to CERIM and the Jean Monnet Lecture series over the past years.



Andrea Broderick was awarded the 2018 Edmond Hustinx Prize for Science for her research on accessibility and universal design obligations as outlined in the Convention on the Rights of Persons with Disabilities (CRPD).
